2. This permit is valid from _____ to _____ between _____ hours and _____ hours for the vehicle/s listed in Part 1 of the permit provided that:
 - a) No vehicle shall enter into Central Expressway (CTE) or Kallang-Paya Lebar Expressway (KPE) Tunnels;
 - b) No travelling during peak hours between **7.00 am and 9.30 am & 5.00 pm to 9.30 pm**;
 - c) The **width** of the vehicle must not exceed **2.60 metres**. (*Width above 2.60m will require a permit and be escorted by Auxiliary Police under Rule 16 of the Road Traffic Rules*);
 - d) The **height** of the vehicle must not exceed **4.50 metres**. (*Otherwise an Auxiliary Police escort is required under Section 79 of the Road Traffic Act*);
 - e) The maximum speed for the vehicle(s) is not exceeded;
 - f) This permit shall be produced for inspection when required by any Police Officer.
3. The police notwithstanding this permit may withdraw this authorisation if any of the provisions above are infringed.
